May be challenging for states to fiscally sustain as Medicaid makes up **28.7%** of state's budget










Private Insurance Shows Greatest Enrollment Gains in Texas



In 2012, Majority of Texas Counties Had Very High Uninsurance Rates Among Low-Income



Counties with Lowest Uninsurance Rates 29.55% Kenedy 30.43% King 33.81% Coryell



By 2016, Substantial Declines in Uninsurance Rates Across Almost All Counties



Virtually All Texas Counties Experienced a Decline in the Uninsurance Rate


What demographic groups face the highest uninsurance rates, and did they see major declines during this period?

Women Have Greater Participation in Public Insurance





Disparities Between Genders Narrowed From 2010-2013




