

- Class of 2023 Bush School graduates were asked to complete a survey to indicate employment and/or enrollment in continuing education. The survey was conducted by the Office of Career & Student Services from graduation in May 2023 to November 2023 (six-months post-graduation) based on professional standards set by the Network of Schools of Public Policy, Affairs, and Administration (NASPAA), representing graduate programs in public administration and public policy across the country.
- Percentages are based on the 95% of graduates (69 of 73 job-seeking graduates) who responded to the survey. Of those responding to our survey, 97% (67 of 69 respondents) were employed or continuing their education within six months of graduating.
