The Scowcroft Institute of International Affairs (SIIA) core mission is to:

Foster and disseminate policy-oriented research on international affairs by supporting faculty and student research, hosting international speakers and major scholarly conferences, and providing grants to outside researchers to use the holdings of the Bush Library.

MAJOR ACCOMPLISHMENTS 2023-2024

Over the past academic year, the Scowcroft Institute of International Affairs focused on refining the speaker series, grant distribution, building programs, and faculty support. Over the past academic year, the Scowcroft Institute has:

- Created the Pandemic & Biosecurity Center through the Board of Regents
- Finalized strategic plan for the Pandemic & Biosecurity Center
- Published policy papers on border health security
- Applied to the Federal Executive Fellowship (FEF) with the Department of the Navy
- Considered moving South Central Review (Editor: Dr. Richard J. Golsan) under the Scowcroft Institute and making it a Bush School Journal
- Increased the number of Scowcroft Senior Fellows to twelve
- Hosted twenty-three, well attended, high-impact, expert lead events to provide faculty, students, and community members with a broad range of expertise on international topics
- Awarded eleven research grants through the Peter and Edith O'Donnell Grant, Korea/Asia Grant, and the Faculty Research Grants to aide scholars doing research in international affairs/policy
- Provided Faculty Support for faculty-led conferences and salary support for research

- Publish policy papers on biosafety of labs studying dangerous pathogens, and threats to the stability of world food systems (that feeds the population of the world)
- Creation of the Scowcroft Student Research Worker Endowment
- Apply to increase number of Army Fellows with the U.S. Army War College Fellowship Program
- Continue to refine and focus the Scowcroft Speaker Series
- Publish "Muddy Water" report on the origins of the Covid-19 Pandemic
- Apply for Korea Foundation grant for a post-doctoral fellowship on North Korea

Programs

The implementation of our strategic programs, Army Fellows, Grants, Pandemic & Biosecurity, French Institute, and Student Outreach, significantly enhances the impact and influence of the Scowcroft Institute and Texas A&M. These programs bolster our reputation, foster collaboration, address critical societal challenges, and attract experts from around the world. By continuing to invest in these initiatives, our institute will remain at the forefront of innovation, research, and knowledge dissemination, driving positive change in the communities the Scowcroft Institute serves.

Senior Fellows

The Scowcroft Senior Fellows program is composed of individuals who are committed to making significant contributions to the development of The Bush School and its mission and objectives. Individuals are invited to be Senior Fellows based on distinguished accomplishments within the individual's discipline and the expertise the individual will bring to collaborations with the Institute.



Christine Blackburn, PhD, Assistant Professor of Health Policy and Management at Texas A&M University, affiliated with the USA Center for Rural Health Preparedness, who conducts research on rural health access, emergency medical services, global health security, and the impacts of immigration law on health, and has authored numerous peer-reviewed articles, policy papers, and books, including on pandemic preparedness and the health impacts of natural disasters, while securing over \$2.5 million in research funding.



Richard J. Golsan, PhD, University Distinguished Professor of French at Texas A&M University and Senior Fellow at the Scowcroft Institute of International Affairs, directs the France/Texas A&M University Institute and edits South Central Review, with research focusing on modern France, Europe, genocides, and historical trials; he has authored or edited over a dozen books, including The Vichy Past in France Today and The Trial That Never Ends, published more than 100 articles, and received the Palmes Academiques from the French government.



Ambassador John Hennessey-Niland, Former U.S. Ambassador to Palau, is a seasoned diplomat with 35 years of experience in the U.S. Foreign Service, having served in various roles including as a National Security Council member at the White House, a UN War Crimes Investigator, and as foreign policy advisor to U.S. Marine Corps Forces Pacific, earning recognition as POLAD of the Year, and being the first U.S. Ambassador to Taiwan since 1979, advocating for increased U.S. engagement with Taipei and leading efforts on climate initiatives, such as ensuring the 2022 Our Ocean Conference was held in the Pacific.



Peter J. Hotez, MD, PhD, Dean of the National School of Tropical Medicine at Baylor College of Medicine and Director of the Texas Children's Center for Vaccine Development, is a globally recognized expert in neglected tropical diseases and vaccine development, leading efforts to create vaccines for diseases like hookworm and Zika, co-founding the Global Network for Neglected Tropical Diseases, and serving as a U.S. Envoy for vaccine diplomacy; an advocate for vaccines and frequent media commentator, he has published over 400 papers, authored influential books, and been honored by the National Academy of Medicine and the WHO, while holding key positions at Texas A&M University, Baylor University, and the Baker Institute for Public Policy.



Glen Laine, PhD, Regent's Professor and Director of the Michael E. DeBakey Institute for Comparative Cardiovascular Science and Biomedical Devices at Texas A&M University, has a diverse background in microbiology, biophysics, and biomedical engineering, and has held prominent roles such as Vice President for Research at Texas A&M, where he led significant growth in research funding and initiated the design of a Biosafety Level-3 AG biocontainment facility, and as a holder of the Wiseman-Lewie-Worth Endowed Chair in Cardiology, he has published extensively on fluid resuscitation in trauma patients and has a keen interest in pandemic

preparedness and bioterrorism.



Quan Li, PhD, Professor of Political Science who focuses his research on topics such as economic globalization, democratic governance, political violence, environmental degradation, and the rise of China, with his work appearing in numerous prestigious journals and several books, including Democracy and Economic Openness in an Interconnected System and Using R for Data Analysis in Social Sciences; he has served as Director of the Program on International Conflict and Cooperation, held positions at Pennsylvania State University, and received accolades like the Best Article on Democratization Award from the American

Political Science Association and a Fulbright U.S. Senior Scholar Award.



Jason Moats, PhD, Director of the Texas A&M Health's USA Center for Rural Public Health Preparedness and Professor of Health Policy and Management, has over two decades of experience in emergency services and training, including developing immersive learning platforms, utilizing robots during the COVID-19 pandemic, and creating augmented reality tools for search and rescue missions, and is recognized for his contributions with awards such as the Texas A&M Regents Fellow Award; he is also a former firefighter and EMT, a veteran of the U.S. Navy, and an author of numerous articles and the book Agroterrorism: A Guide for First Responders, holding multiple certifications in homeland security, teaching, and emergency management.



Elsa A. Murano, PhD, After serving as Undersecretary for Food Safety under President Bush and meeting foodborne illness reduction goals early, Dr. Murano returned to Texas A&M University, where she became the first woman and first Hispanic President, later leading the Borlaug Institute for International Agriculture to support small farmers worldwide, and now serves on the boards of Hormel Foods, Blue Bell Creameries, and the CGIAR International Livestock Research Institute, with honors including induction into the U.S. Meat Industry Hall of Fame and the Texas Woman of

the Year Hall of Fame.



Ren Mu, PhD, Holds the Robert H. and Judy L. Allen Professorship and is a Professor specializing in empirical microeconomics within development economics, focusing on household and individual decision-making in developing countries, with research spanning human capital outcomes, rural-urban migration, and public investment effectiveness; she earned her PhD in economics and MS in statistics from Michigan State University, and teaches courses on the global economy, economic development in China, and advanced economic development at the Bush School, along with study abroad seminars and Capstone projects.



Gerald Parker, PhD, Associate Dean for Global One Health at the College of Veterinary Medicine & Biomedical Sciences and Campus Director for Global One Health at Texas A&M University, also holds joint appointments as Director of the Biosecurity and Pandemic Policy Center at the Scowcroft Institute and as a strategic advisor at AgriLife Research; with 36 years of public service in biodefense and public health, he has led responses to major crises, including Hurricanes Katrina and the 2009 Pandemic, held senior positions at DHS, HHS, and DoD, and earned honors such as the Distinguished Executive Presidential Rank Award and the Secretary of Defense

Medal for Meritorious Civilian Service.



Oyewale Tomori, DVM, PhD, FRCPath (UK), FCVSN, FASTMH, FAS (Nigeria), NNOM, NAM, Immediate past President of the Nigerian Academy of Science, has extensive experience in virology, disease prevention, and control, having served as a virologist for WHO's Africa Region, established the African Regional Polio Laboratory Network, and been recognized by the CDC for his work on Lassa fever; he was the pioneer Vice Chancellor of Redeemer's University, has received the Nigerian National Order of Merit, authored over 150 scientific publications, and serves on numerous national and international advisory committees, including WHO SAGE, the GAVI Board, and

the U.S. National Academy of Medicine Global Health Risk Framework Commission, while currently chairing the Board of Biovaccines Nigeria Ltd.



Edward You, Supervisory Special Agent in the FBI's Weapons of Mass Destruction Directorate detailed to the U.S. Department of Health and Human Services, coordinates and enhances FBI and interagency efforts to address biological threats, focusing on emerging biotechnology challenges and safeguarding the scientific community and U.S. bioeconomy; he has previously served on the FBI Los Angeles Field Office Joint Terrorism Task Force and the Hazardous Evidence Response Team, contributed to biosecurity policy-making with the National Security Council and NIH, and has been involved in National Academies committees on microbial threats and

synthetic biology, following a career in retrovirology, human gene therapy, and cancer research.

Army Fellows

As part of the United States Army War College's Senior Service College Fellowship Program, the Scowcroft Institute hosts officers as Fellows for one academic year. This program promotes cooperative academic exchanges between selected United States Army officers and civilian educational and teaching facilities. The program is designed to promote research on topics of strategic relevance, increase the knowledge and awareness of military affairs, foster cooperation, and intellectual exchange, and enhance the strategic thinking and research skills of the mid-career army officers selected to take part in the institute's fellowship program.

While in residence at the Scowcroft Institute, Army Fellows:

- Complete a research project on a topic of strategic relevance to the Army and the Institute.
- Participate in coursework at the Bush School and in other Texas A&M University departments.
- Attend lectures, workshops and conferences hosted by the Scowcroft Institute.
- Bring in outside experts to lecture on military affairs and strategy.
- Engage students and faculty by giving lectures about their research and career experiences.

SIIA welcomed two new Army Fellows during fall 2022.



Colonel Fin P. Carey holds a Bachelor of Science in Public Relations from the University of Central Missouri and a Master of Arts in Management and Leadership from Webster University. After enlisting in the Army in 1992 and joining the Missouri National Guard in 1995, he was commissioned as an Aviation Officer in 2000 and has since held several key leadership roles, including Commander of multiple aviation battalions and Missouri National Guard State Army Aviation Officer. Colonel Carey, a highly decorated officer and qualified instructor pilot, currently commands the Army Aviation Support Facility at Whiteman Air Force Base.



Lieutenant Colonel Robert M. M. Gichert was commissioned as a Second Lieutenant of Armor from the United States Military Academy in 2003 and began his career as a Scout Platoon Leader in Baghdad. He has since held multiple leadership roles, including Executive Officer for the 3rd Brigade, 1st Cavalry Division, and Commander of the Warrior Transition Unit at Naval Medical Center San Diego, with deployments supporting OPERATION ENDURING FREEDOM and OPERATION SPARTAN SHIELD. His distinguished service, including key assignments as Operations Officer for

2-7 Cavalry and Special Assistant to the Director of the Army Staff, has earned him numerous awards, such as the Bronze Star and the Combat Action Badge.

The 2023-2024 Army Fellows, Colonel Fin P. Carey and Lieutenant Colonel Robert M.M. Gichert successfully completed their appointments as U.S. Army War College Fellows. In spring 2024:

Research Grants Overview

The Scowcroft Institute currently has three grant research programs to assist scholars with policy-relevant research on international affairs. The George & Barbara Bush Foundation has instituted two research grant programs under the Institute to assist scholars doing research at the George Bush Presidential Library; they are the O'Donnell Grant Program and the Korea/Asia Grant Program. Funding priority is given to proposals that a) have the greatest likelihood of publication and subsequent usefulness to educators, scholars, students, and policymakers, and b) bring newly available research materials to light.

Peter and Edith O'Donnell Grants

The Peter and Edith O'Donnell Endowment Grant Program in the Scowcroft Institute of International Affairs provides grants to aid scholars doing research at the George Bush Presidential Library. Research must include, but is not limited to, holdings of the George Bush Presidential Library. Funds are awarded for the sole purpose of helping to defray living, travel, and related expenses incurred while conducting research at the George Bush Presidential Library.

Biosecurity and Pandemic Policy Center

The Biosecurity and Pandemic Policy Center (BP2) is an educational, research, and policy program targeting current challenges in biosecurity and pandemic preparedness and response. The Center was created by vote of the Board of Regents in August 2024. The Center's goal is to place the Scowcroft Institute, The Bush School of Government and Public Service, and Texas A&M University as an international leader in biosecurity and pandemic preparedness through education, research, and work in the policy arena.

Dr. Gerald Parker, Director of the Biosecurity and Pandemic Policy Center, Associate Dean for Global One Health at the College of Veterinary Medicine & Biomedical Sciences, and Campus Director for Global One Health at Texas A&M University, has represented the Center to external partners throughout 2023. Many of these engagements were supported by staff of the Center based in both Texas and the Bush School DC Campus.

The Center maintains an online platform, the Scowcroft Infectious Disease Information Platform (SIDIP), with the goal of creating a high-quality, centralized location for information on infectious disease that is accessible to scientists, policymakers, and the public.

The vaccine hesitancy in Africa project, led by Dr. Christy Blackburn, Dr. Tim Callaghan, Dr. Brian Colwell, has been published. They, along with three student workers and one Ph.D. candidate, used data from on-the-ground interviews, surveys, and research in Nigeria, South Africa, and Ghana collected over the summer of 2023. The project is believed to be the first academic paper using interview and survey data in Africa focused directly on this issue.

Planned Events:

- The Center will hold the annual Scowcroft Pandemic Summit from January 21-23, 2025 at the Annenberg Presidential Conference Center. This summit will focus on the ongoing outbreak of H5N1 Highly Pathogenic Avian Influenza (HPAI) in cattle in Texas, nationally, and internationally. The outcome will be a document for publication.
- The Center's proposal to the National Science Foundation was recommended for funding. The proposal is to hold a workshop on capturing benefits and mitigating risks of AI tools in the life sciences.

2023-2024 Summits and Events:

• Public Health at the Texas Border and in Rio Grande Valley: The Center rebooted the annual Scowcroft Pandemic Summit for the first time since 2019 and the start of the COVID-19 pandemic. The 2023 Summit was held at the Annenberg Presidential Conference Center in

College Station from November 5 to 7, 2023. This summit focused on Border Health and brought together scholars, policy makers, emergency managers, and public health practitioners to discuss the unique challenges and opportunities associated with health resilience near the trans-border regions of southern United States, Mexico, and Central America. A final report based on the Summit has been prepared and is undergoing final review for publication.

- Artificial Intelligence and Biosecurity: In December 2023, the Center hosted a workshop at Texas A&M University DC with 17 participants titled "Taking Stock of the AI-Biosecurity Policy Discussion."
- Agricultural Biosecurity and Implementation of NSM-16: In February 2024, the Center hosted a virtual panel on Biological Threats to Agriculture and on the implementation of the 2022 National Security Memorandum on Strengthening the Security and Resilience of United States Food and Agriculture. Guests included former NSC staff who worked on the Memorandum, an academic expert on crop genetics from the University of Maryland, Dr. Seth Murray, a Texas A&M expert on maize breeding, a biotechnology expert working on threats to agriculture, and a biotech company working on microbial production of fats.
- Expanding Global Vaccine Manufacturing Capacity: The Center hosted an in-person, moderated Chatham House discussion with 25 experts from industry, nongovernmental organizations, and former leaders of federal agencies, such as the Biomedical Advanced Research and Development Authority (BARDA). The purpose of the meeting was to develop a white paper with recommendations useful to NGOs and public or private sector funders interested in effectively supporting the development of vaccine manufacturing capacity, especially in low and middle income countries. The paper will include several case studies on the successes and failures of past and ongoing initiatives.
- Artificial Intelligence in Healthcare and Medical Supply Chains: The Center hosted an in-person panel discussion at the Texas A&M University DC site about the implications of new data technologies and AI for health care delivery, and how these trends intersect with evolving challenges in the global supply chains of medical supplies.
- Started a workshop discussion series in June 2024 around the 2024 White House Policy on Dual Use Research of Concern and Pathogens with Enhanced Pandemic Potential, Biosafety and Biosecurity Oversight in the United States. The workshops are also forums for discussing public policy around existing proposals for independent oversight of high-risk pathogen research.

French Institute of Texas A&M University (Centre d'Excellence)

The French Institute of Texas A&M University (Centre d'Excellence) was founded in 2008 with the support of the French Cultural Services and French Embassy and the Office of the Provost at Texas A&M University. The French Institute of Texas A&M University (Centre d'Excellence) is one of twenty-three Centres d'Excellence or Centers of Excellence created by the French Cultural Services with prestigious American partner universities.

The purpose of the French Institute of Texas A&M University (Centre d'Excellence) and the Centers of Excellence is to foster Franco-American cultural and intellectual exchanges in the form of sponsored lectures and colloquia involving French and American scholars, public intellectuals, as well as others. The Centers also encourage and contribute to curricular enhancements and student and teacher exchanges with France.

Housed in the Bush School and the Scowcroft Institute, the French Institute of Texas A&M University (Centre d'Excellence) works with other entities within the University including the Glasscock Center for Humanities Research, the Department of International Studies, and the Dean of Faculties Office in sponsoring events on campus. The Founding Director of the French Institute of Texas A&M University (Centre d'Excellence) is University Distinguished Professor and Senior Scowcroft Fellow Richard J. Golsan. The Advisory Board consists of Andrew Natsios, Director of the Scowcroft Institute, Leslie Ruyle, Associate Director of the Scowcroft Institute, Associate Provost and Professor of Spanish Sarah Misemer, and Associate Dean for Faculty Affairs for the College of Arts & Sciences and Professor of Global Languages & Cultures Stefanie Harris.





SIIA Events & Research



SIIA Events & Research




