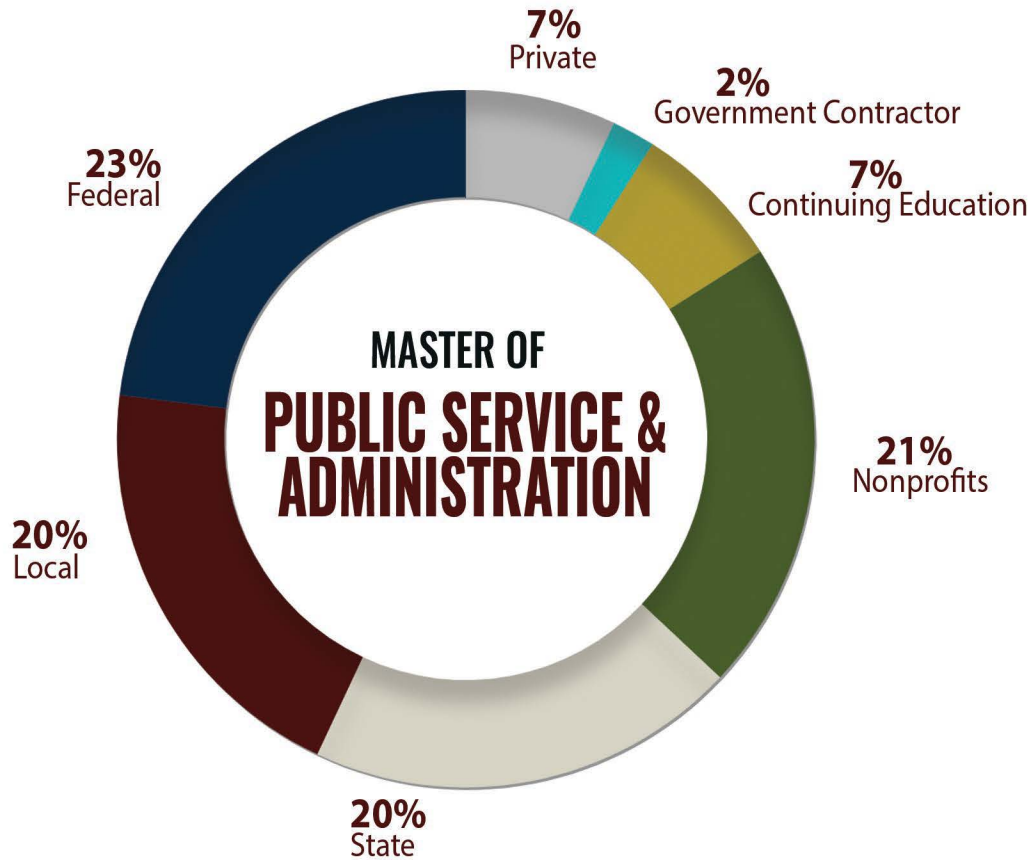

Class of 2024 Bush School graduates were asked to complete a survey to indicate employment and/or enrollment in continuing education. The survey was conducted by the Office of Career & Student Services from graduation in May 2024 to November 2024 (six-months post-graduation) based on professional standards set by the Network of Schools of Public Policy, Affairs, and Administration (NASPAA), representing graduate programs in public administration and public policy across the country.



Percentages are based on the 86% of graduates (70 of 81 job-seeking graduates) who responded to the survey. Of those responding to our survey, 94% (66 of 70 respondents) were employed or continuing their education within six months of graduating.
